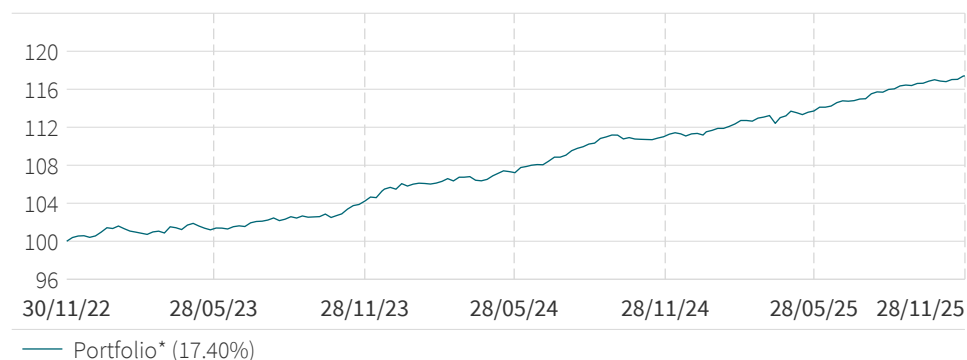

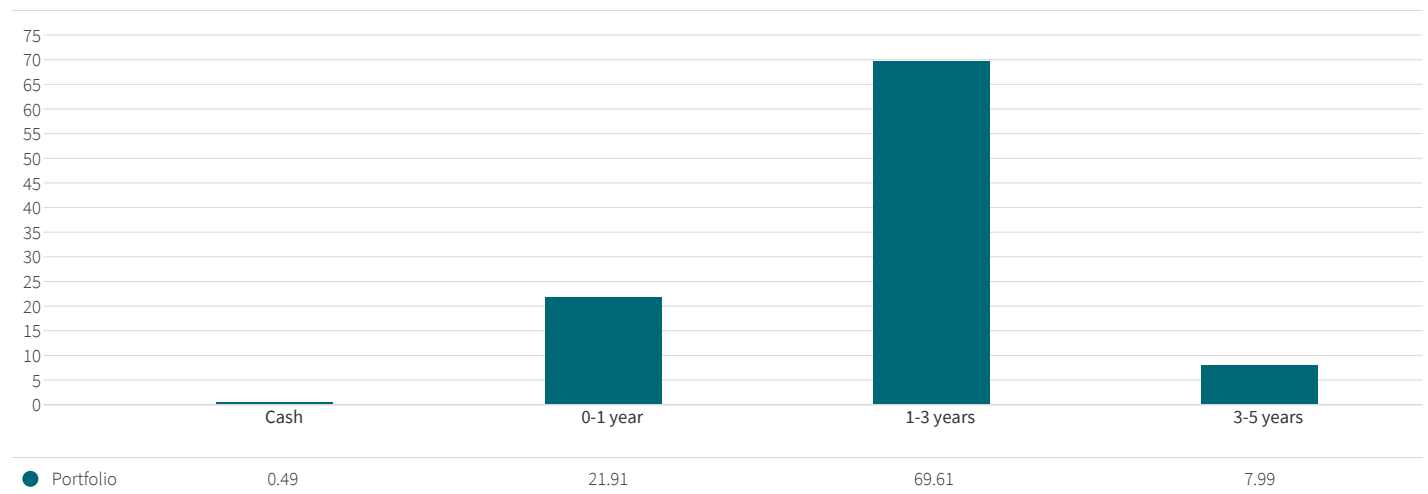

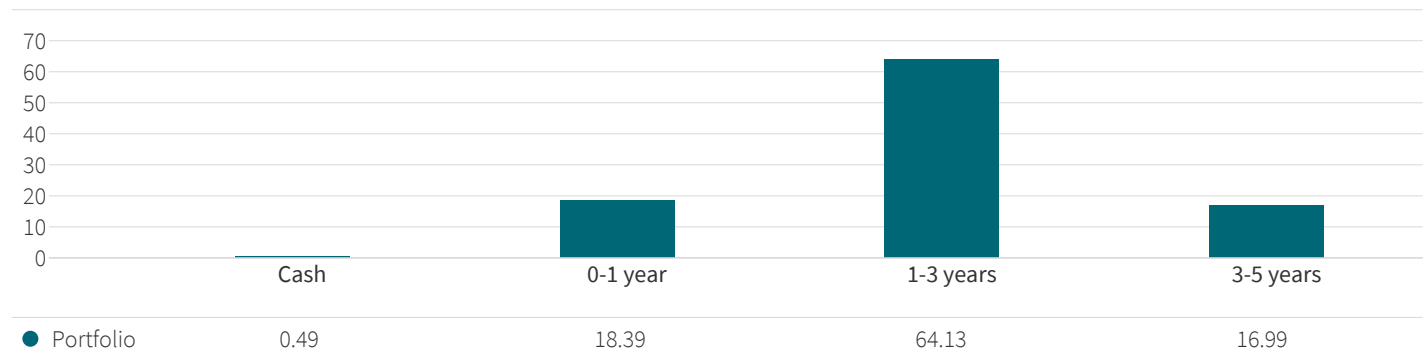

### Maturity Breakdown (%)



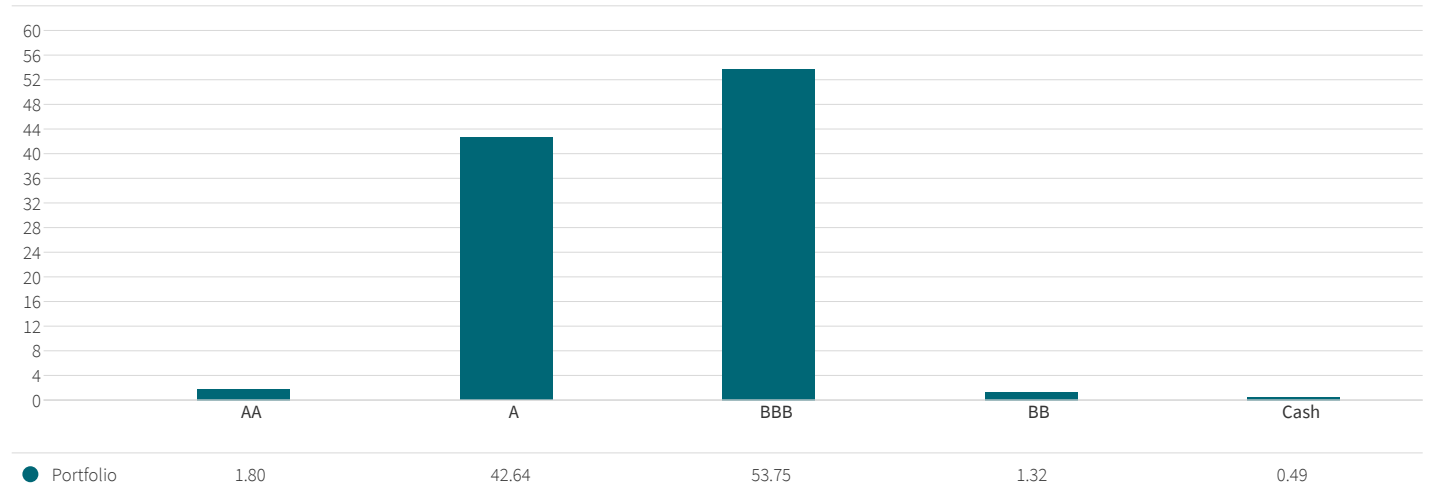

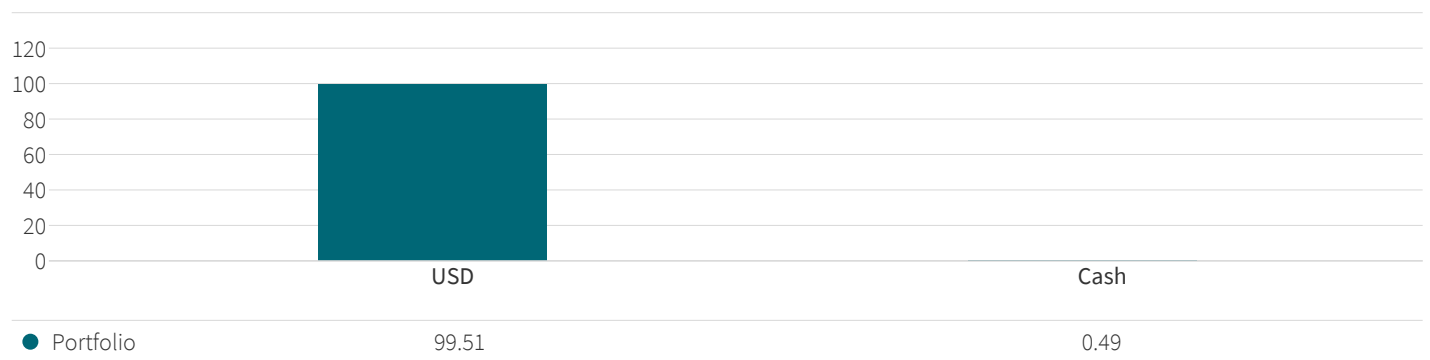
