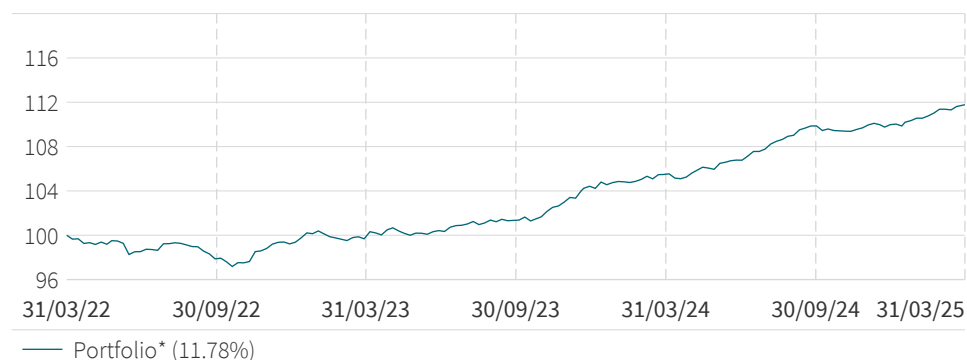

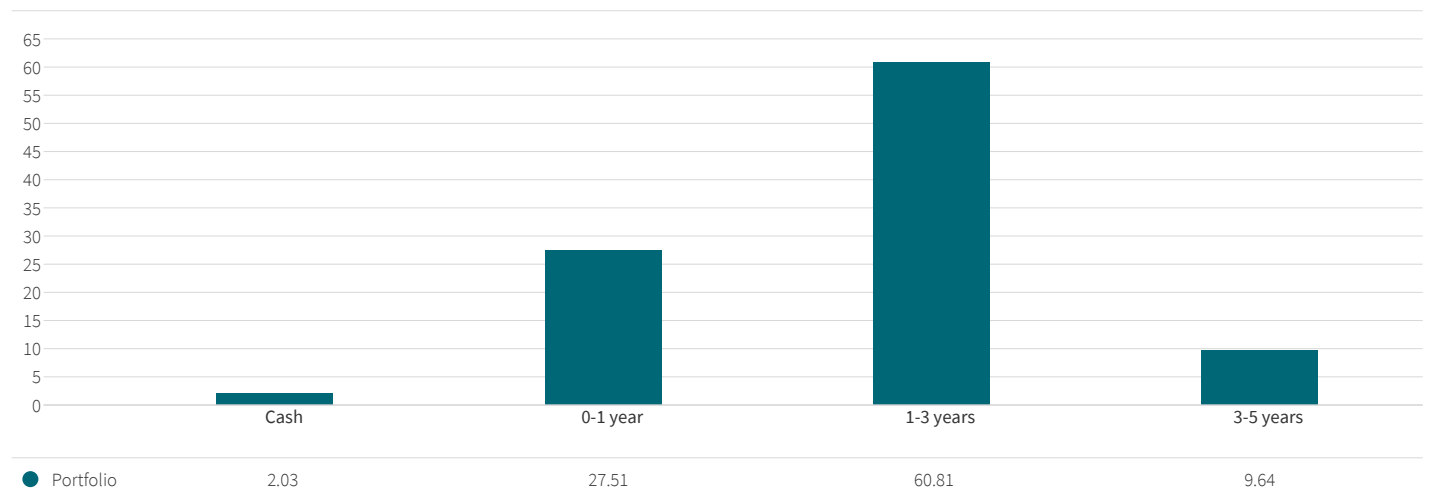

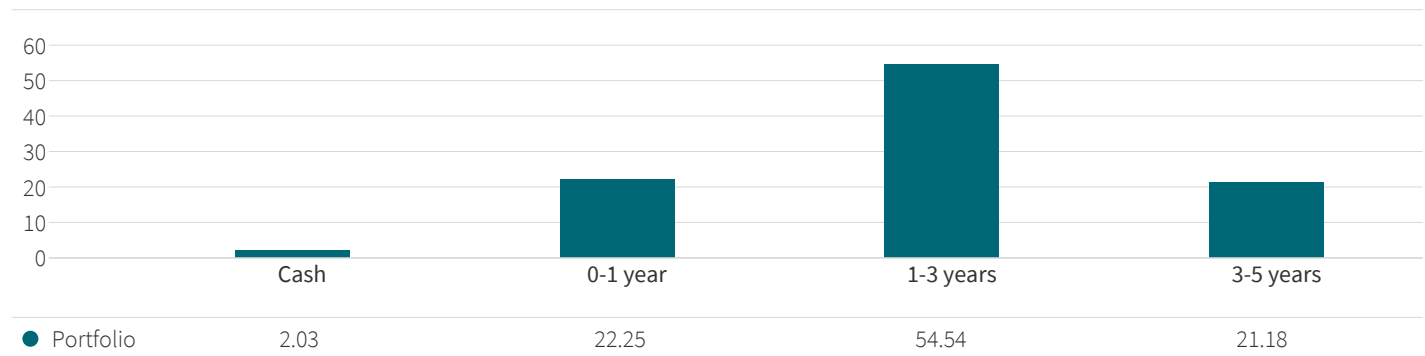

Maturity Breakdown (%)



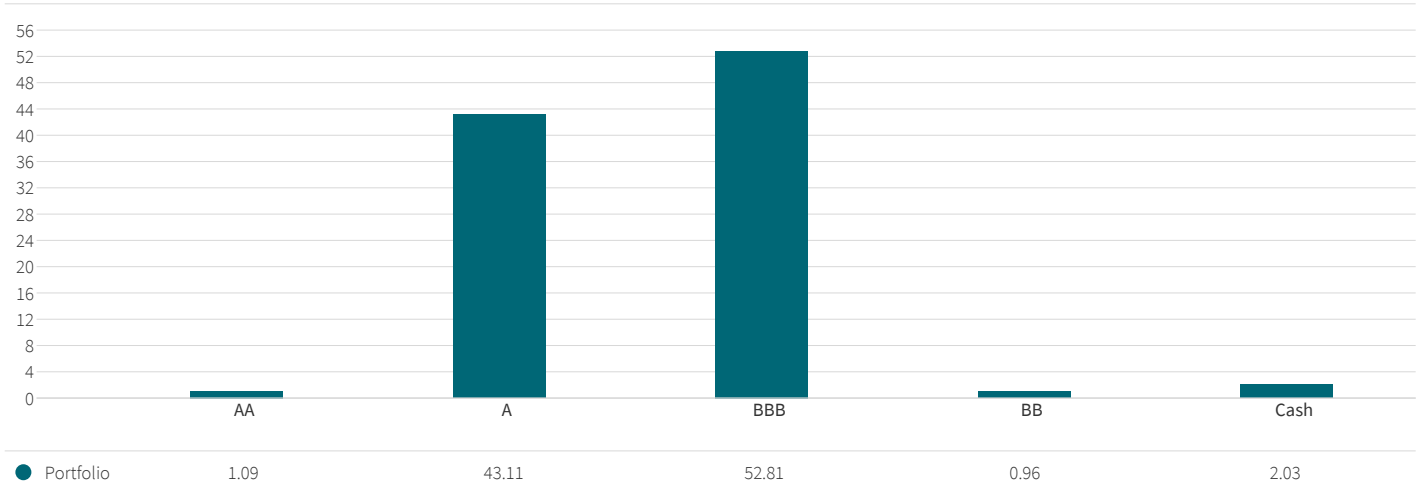

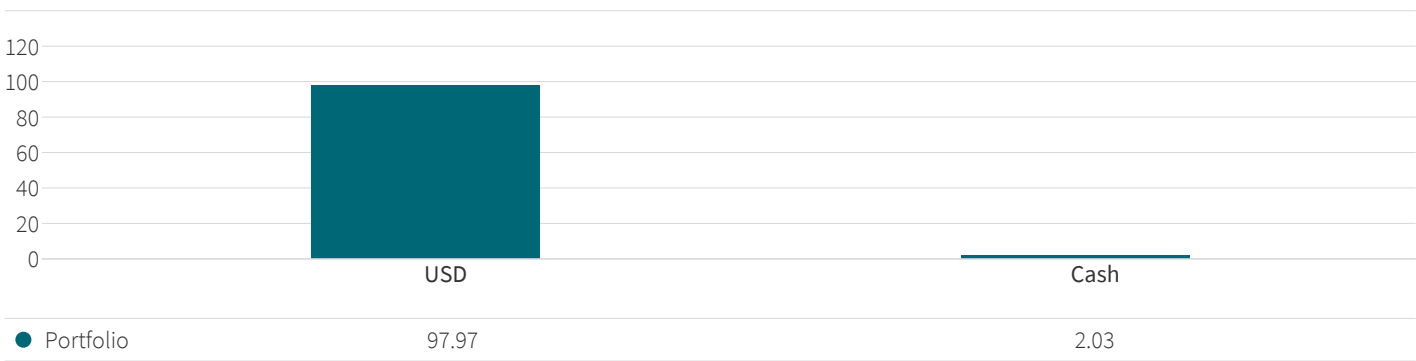
